Dear Ms. Myers:

I am in receipt of your renewal request and would like to thank you for the opportunity to renew Virginia State Vehicle Contract 505-13-CC0009 for 14 Passenger Ford Vans. All of us at Sonny Merryman, Inc. appreciate the opportunity to continue providing this vehicle to municipalities and agencies here in the Commonwealth.

Upon receipt of your letter, I submitted a request to the manufacturers for 2017 model year pricing. The Ford chassis price for the 2017 model increased by \$853.00 when compared to the 2016 model. The body manufacturer, Starcraft, is requesting a 1.2% body increase for the 2017 model year. That amount will be \$266.00. Our actual per unit increase is \$1,119.00. Documentation is attached.

The 2016 model year price was \$46,357.00. I would like to request a new 2017 model year price of \$46,913.00. While the requested price does not cover our actual increase it is within the limits allowed per contract language.

Contract language allows an annual increase based on Producer Price Index Series WPU141302. For the most recent 12 month period posted, the allowable increase is \$556.28. The relevant Producer Price Index Table is attached. The amount was determined as follows:

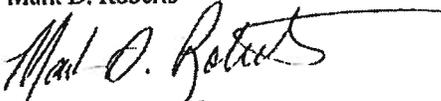
- April 2015 factor = 236.8
- April 2016 factor = 239.6

$$239.6 - 236.8 = 2.8 \quad 2.8 / 236.8 = .012 \quad \$46,357.00 \times 1.012 = \$46,913.00$$

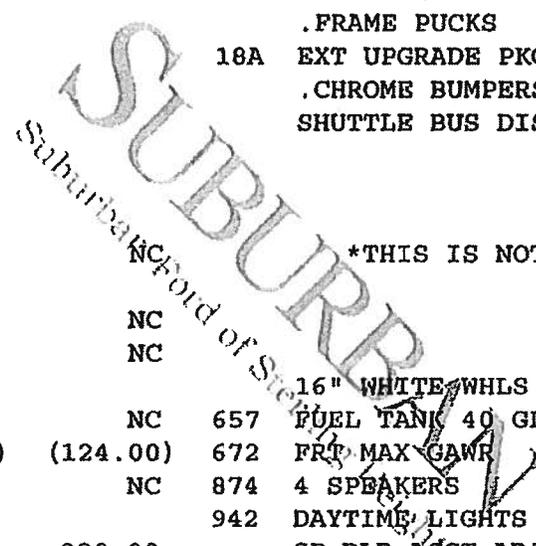
