I am in receipt of your renewal request and would like to thank you for the opportunity to renew Virginia State Vehicle Contract 505-13-CC0003, Lot 1 for 14 Passenger Chevy Vans. All of us at Sonny Merryman, Inc. appreciate the opportunity to continue providing this vehicle to municipalities and agencies here in the Commonwealth.

Upon receipt of your letter, I submitted a request to the manufacturers for 2018 model year pricing. The Chevrolet chassis price for the 2018 was unchanged when compared to the 2017 model. The body manufacturer, Starcraft, is requesting a body increase of \$224.00 for the 2018 model year. Our total per unit increase is \$224.00. Documentation is attached.

The 2017 model year price was \$47,159.00. I would like to request a new 2018 model year price of \$47,383.00. The requested price it is within the limits allowed per contract language.

Contract language allows an annual increase based on Producer Price Index Series WPU141302. For the most recent 12 month period posted, the allowable increase is \$518.75. The relevant Producer Price Index Table is attached. The amount was determined as follows:


- October 2016 factor = 240.5
- September 2017 factor = 243.1

$$243.1 - 240.5 = 2.6 \quad 2.6 / 240.5 = .011 \quad \$47,159.00 \times .011 = \$518.75$$
